INVESTMENT STRATEGY

Since 2007, ODDO BHF Polaris Flexible has offered a global and broadly diversified, flexible multi-asset investment solution. It is characterized by a flexibly managed equity allocation between 25% and 100% and a bond segment that invests mainly in investment grade bonds. The portfolio may invest in securities listed or traded on regulated markets, mainly in Europe, the US or Emerging Markets.

The investment objective is to participate as much as possible in the appreciation of rising equity markets, but to limit losses in downward movements. At the same time, environmental, social and corporate governance (ESG) criteria are to be taken into account in the investment.

ASSET ALLOCATION

MONTHLY MANAGEMENT COMMENT

International capital markets have recently been heavily influenced by the war in Iran. The announcement of a ceasefire and the start of negotiations between the US and Iran initially led to a noticeable easing of tensions. This triggered a recovery rally on the financial markets, which was more subdued in Europe than in the US. Once again, technology stocks were the focus of attention. Solid quarterly results also provided a tailwind. Uncertainty was fuelled by the ongoing blockade of the Strait of Hormuz and the repeatedly stalled peace negotiations. After initially falling, the oil price rose sharply again towards the end of the month. Against the backdrop of ongoing risks associated with the Iran conflict, we hedged the portfolio at the start of the month with a put option on the EuroStoxx 50. Following the strong performance of US technology stocks in April, we closed this hedge and opened a position in the S&P 500 instead. In addition, given high valuations, we took profits on US technology stocks such as Broadcom, Alphabet and Amphenol. Following similarly strong price performance, we reduced our holdings in Siemens Energy and ASM International. We sold our position in Mercedes following a disappointing performance. New additions to the portfolio were Lam Research, a manufacturer of equipment for the semiconductor industry, and the software provider Cadence Design Systems.

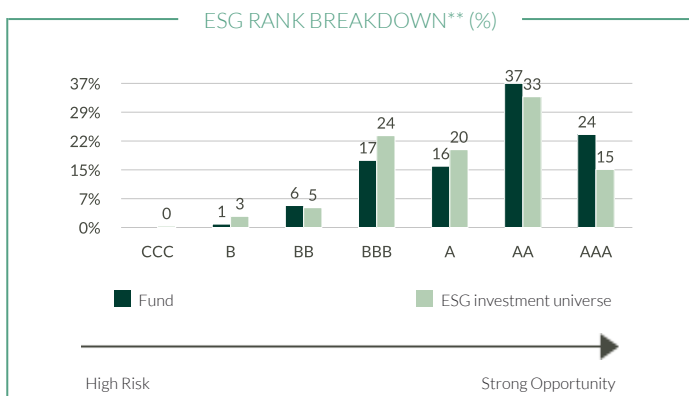
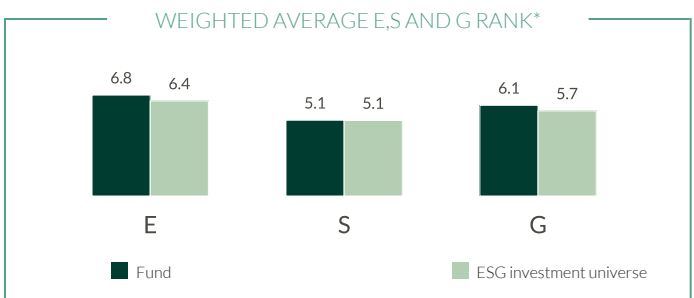

SUSTAINABLE REPORT – METHODOLOGY

ODDO BHF AM considers that measuring the environmental, social and governance impact of an investment is an essential step in disseminating good practices in ESG integration. To do this, it is imperative to have reliable, simple quantitative criteria (no reprocessing) and to allow comparison between portfolios regardless of their composition (large vs midcaps, geographical and sectoral diversity).

The choice of indicators is therefore crucial for the relevance of impact measurement. The data for the environmental indicators come from our external non-financial analysis provider, MSCI. We systematically indicate the availability of the data at the level of the portfolio and its benchmark.

ESG integration at ODDO BHF Asset Management | 3 systematic steps

Exclusions

- Norm-based:** exclusion of companies that do not comply with certain international standards.(chemical weapons , anti-personnel mines, violation of the principles of the Global Compact, etc.)
- Sector-based:** total or partial exclusion of sectors or activities based on ethical considerations (tobacco, gambling, weapon, adult entertainment / pornographie and Coal...)

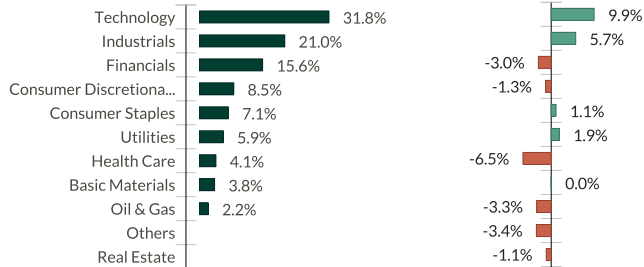

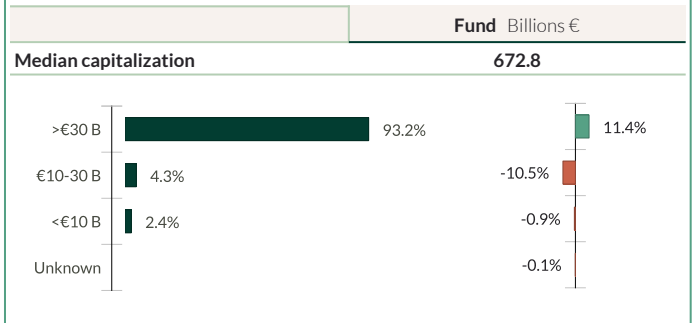

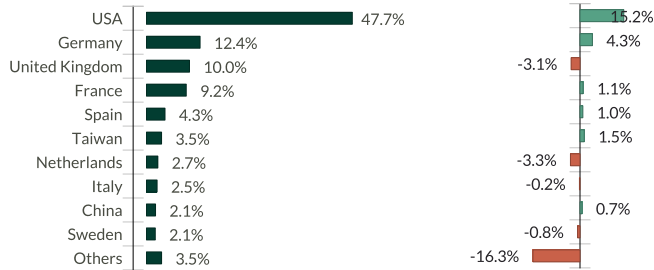
SECTOR BREAKDOWN



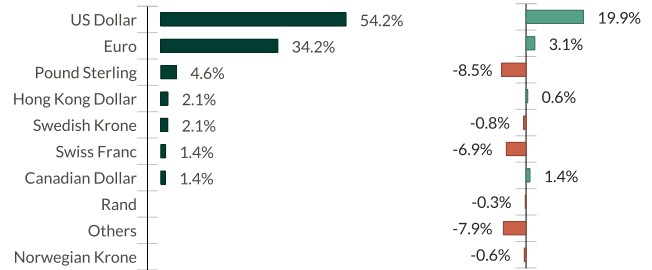
MARKET CAP BREAKDOWN - EXCLUDING CASH

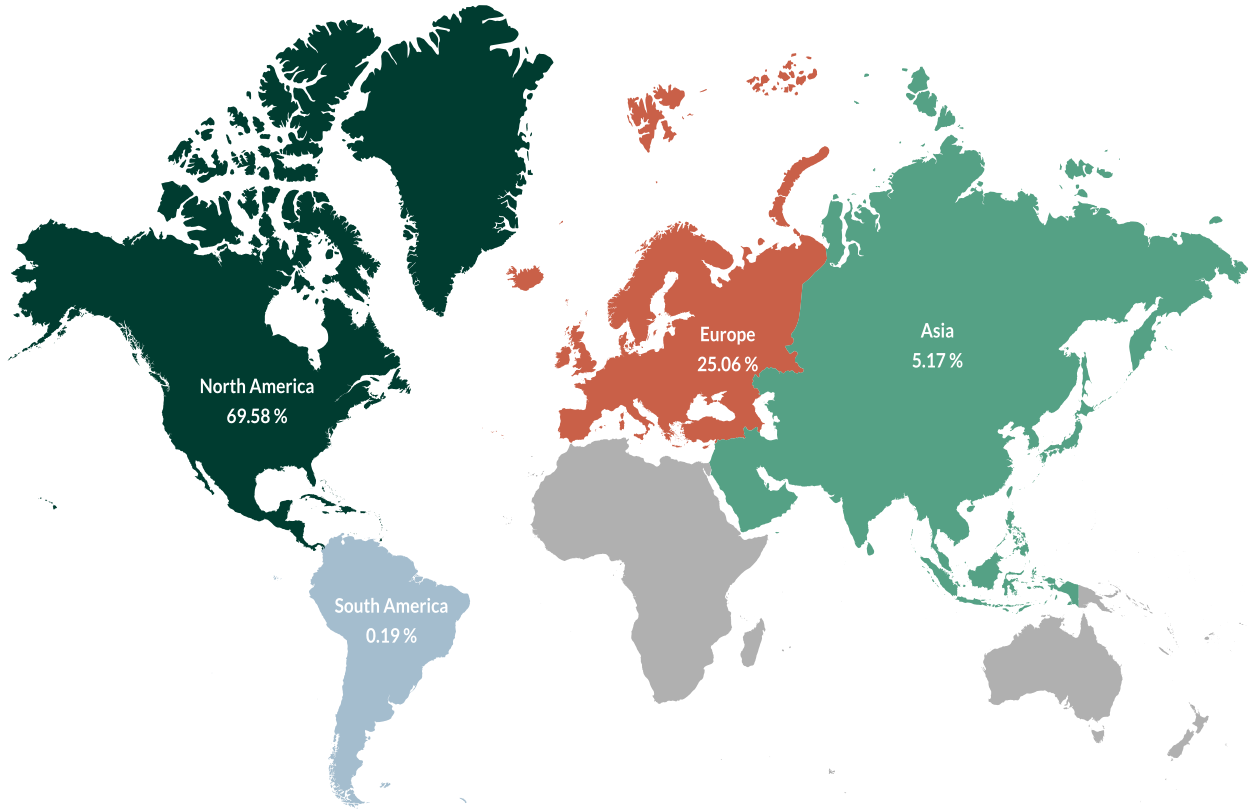

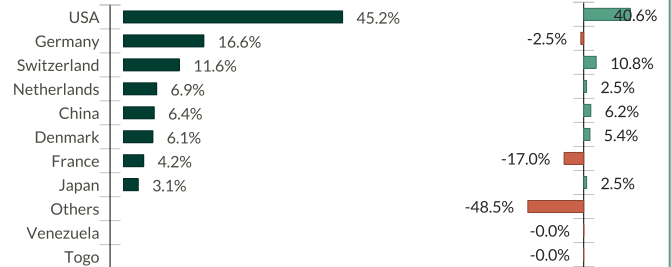

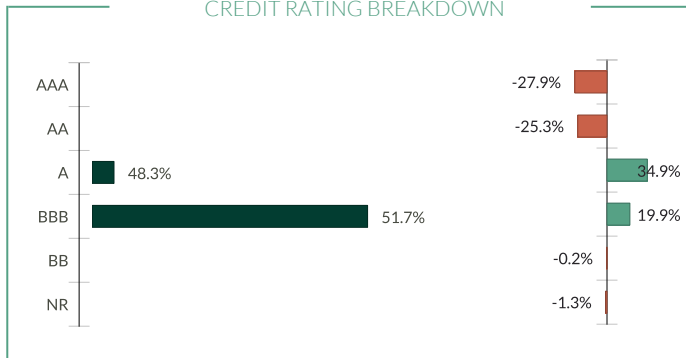

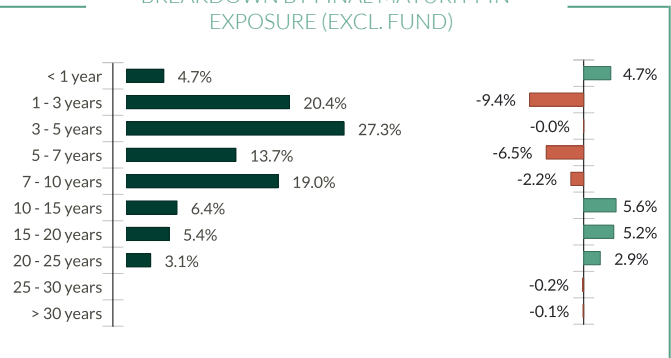
GEOGRAPHIC BREAKDOWN (COUNTRY OF RISK)
