## Objectives and investment policy

ODDO BHF Algo Global CRW-EUR invests in shares worldwide.

Shares are selected for the Fund using a quantitative model. This model is used to evaluate shares in major worldwide companies based on their value, momentum (stock price dynamics), risk, growth and earnings revision (changes in the profit forecasts of analysts observing the company).

The best shares in each category are included in the Fund; the composition is reviewed quarterly.

The aim of an investment in ODDO BHF Algo Global CRW-EUR is to share in the performance of the worldwide equity market.

The Fund is based on MSCI World (EUR, Net Return)<sup>®</sup> as the benchmark\*, however, the Fund does not replicate the benchmark exactly and instead strives to exceed the performance of the benchmark, meaning that significant deviations, both positive and negative, are possible. The objective is an performance independent of the benchmark. The Fund is actively managed to seek out promising investments from which good performance can be expected. The

benchmark is only one of several indicators used in taking investment decisions for portfolio management. Stock selection and asset allocation decisions are also based on in-depth market analyses and macro-economic studies. Research services and fundamental qualitative and/or quantitative analyses are further cornerstones of the active decision-making process. In addition, a top-down approach, bottom-up approach or a combination of both is used.

ODDO BHF Algo Global CRW-EUR has been specifically established for retail investors.

The Fund may potentially not be suitable for investors wishing to withdraw their capital from the Fund within a period of 5 years.

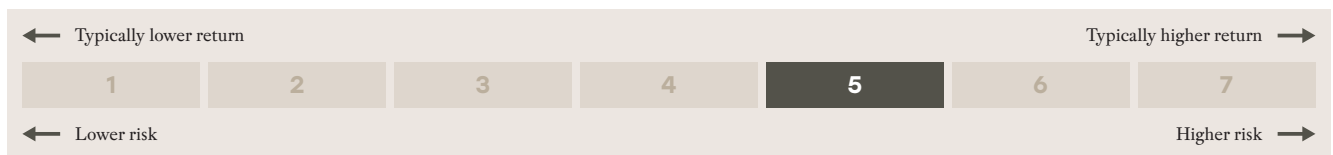
The currency of the Fund is the Euro.

## Risk and reward profile



The Fund is classified into its risk class on the basis of historical data of the Fund or a comparable investment in the last 5 years; the classification therefore does not represent any forecast for the future. The classification is not a guarantee; it can change over time. A classification into category 1 does not mean that a Fund is not subject to any risk of fluctuation in its value.

The Fund is classified into risk class 5 because the historical data show value fluctuations of between 10% and 15% on an annual average.

Generally, higher value fluctuations will entail greater risks of loss, but also greater opportunities for value increases.

The following risks do not have any direct influence on the classification but may nevertheless be of significance for the Fund:

- **Operational risks including custody risks:** Errors and misunderstandings in management and custody may adversely affect the performance of the Fund.
- **Model risks:** The Fund selects its investments based on a quantitative model. The forecasting accuracy of this model may decrease.
- **Currency risks:** The Fund also invests its monies outside the Euro area. The value of the currencies of these investments may fall against the Euro.

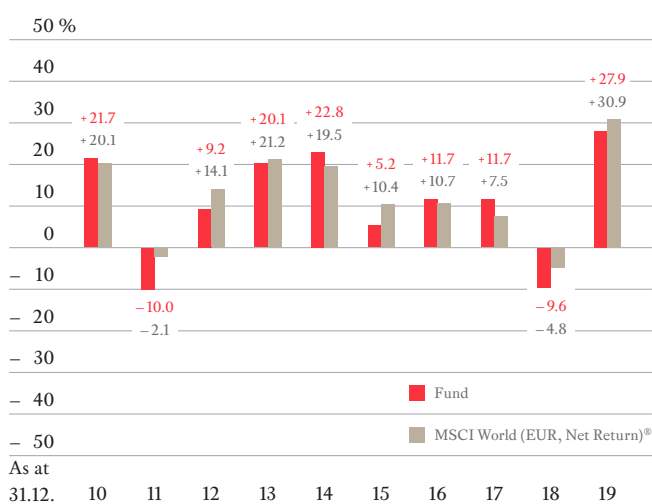
The charges borne by you finance the management and custody of the Fund as well as distribution and marketing; these charges reduce the growth potential of your investment.
