The Fund is treated as a Transparent Reporting Fund and as such is treated as tax transparent. For tax purposes the Funds' income and expenses are deemed to arise directly in the hands of the investors. Income held by the Fund are not taxed when they are realised and instead a taxable capital gain or loss is realised.

The Fund does not operate equalisation for UK tax reporting purposes, and all amounts are reported on a net basis.
