INVESTMENT STRATEGY

ODDO BHF Global Target IG 2029 is a fixed-maturity fund maturing in December 2029. The fund aims to increase the value of the portfolio, in the medium and long term, through the discretionary selection of at least 80% Euro denominated investment grade corporate bonds. The fund will implement its investment strategy over an investment period through to a maturity date set by the Management Company (31 December 2029). The selection of individual bonds is based on a proven investment process which combines fundamental credit research, an in-depth analysis of each issuer as well as disciplined and reactive risk management.

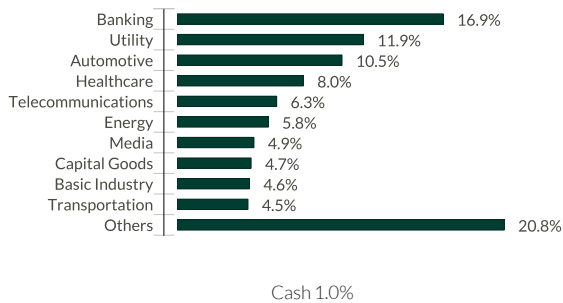

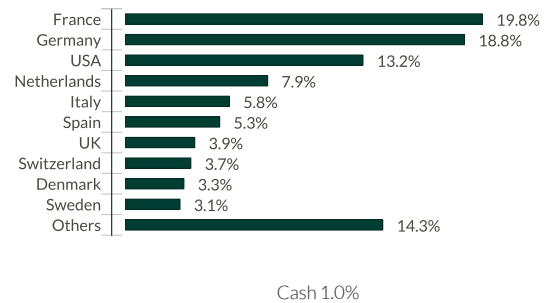

SECTOR BREAKDOWN

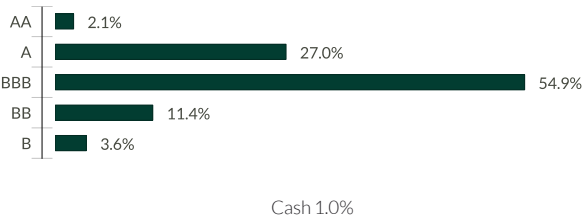

GEOGRAPHIC BREAKDOWN (COUNTRY OF RISK)

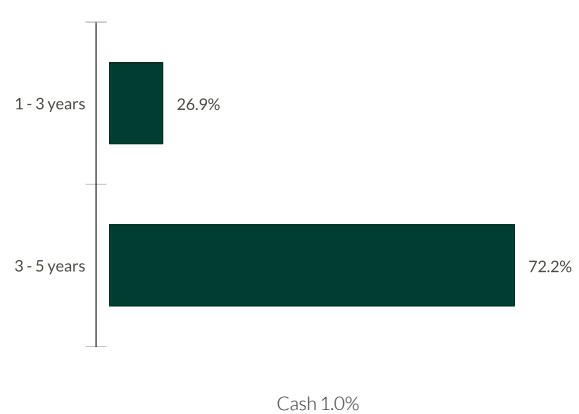


CREDIT RATING BREAKDOWN

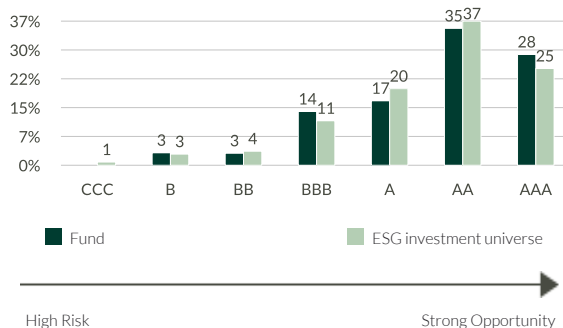

SUSTAINABLE REPORT – METHODOLOGY

ODDO BHF AM considers that measuring the environmental, social and governance impact of an investment is an essential step in disseminating good practices in ESG integration. To do this, it is imperative to have reliable, simple quantitative criteria (no reprocessing) and to allow comparison between portfolios regardless of their composition (large vs midcaps, geographical and sectoral diversity).

The choice of indicators is therefore crucial for the relevance of impact measurement. The data for the environmental indicators come from our external non-financial analysis provider, MSCI. We systematically indicate the availability of the data at the level of the portfolio and its benchmark.

Carbon metrics methodology: We updated our methodology of carbon intensity calculation.

Starting January 31st, 2023, when reported carbon values are unavailable or inconsistent, estimated carbon values are used.

The estimations are based on average carbon value (scope 1+2 emissions) of sectoral peers as a function of revenues

MONTHLY MANAGEMENT COMMENT

The ceasefire agreement signed between Iran and the United States in June didn't last long and was violated less than a month later by renewed attacks from both sides resulting in a surge in oil prices and a selloff in rates. Despite renewed tensions, risk markets remained broadly calm with no major widening over July. One of the key reasons for the robust risk environment has been the resilience of economic data. In the US, consumer spending remained robust despite a low savings rate and weak wage growth. At the same time investments were driven by the ongoing spending for the buildout of AI infrastructure. The labor market cooled off from the previous strong months in May and June but remained on a broadly stable trajectory with little hiring and very low layoffs. Even core inflation surprised strongly to the downside in June with a rare 0% month over month print. While the Federal Reserve kept rates unchanged, investors remain uncertain about the future trajectory of monetary policy under the new Fed Chair. Warsh, a notable critic of central bank forward guidance gave unclear and conflicting cues about his own views on the economy and the Fed's reaction function in his second press conference prompting a steepening of the yield curve as a result. In the Eurozone preliminary Q2 GDP data surprised to the upside with 0.4% growth QoQ and confirmed the surprising resilience we saw over the last months, despite the Middle East conflict. The ECB kept the policy rate unchanged as expected and continued to stress their flexible and data dependent approach which would likely result in the next rate hike in September if current conditions remained in place. Markets had already discounted this outcome and are currently pricing an additional third hike beyond the September meeting. The Q2 earning season started on a strong footing and with minor exceptions such as in Automotive, results have generally been solid and beat expectations. The main market mover in credit this month were bonds from the hyperscalers such as Amazon or Google. Their spreads widened notably on the back of ongoing supply which is likely to continue going forward driven by the ongoing surge in capital expenditures leading investors to demand a higher premium, especially for longer dated bonds. Despite these relative moves under the surface, on an index level both Corporate Investment Grade Bond and High Yield spreads remained broadly unchanged over the course of the month. German 10yr Bund yields increased to 3.20% while US 10yr treasury yields underperformed, increasing to 4.73%.

The fund recorded a negative absolute performance due to the selloff in rates. The risk profile of the fund has been left unchanged.
